Where to apply:

Residents of Mainland China can apply at the Embassy in Beijing or the Consulates General in Shanghai or Guangzhou, according to the ADS MOU and where their passport or Hukou was issued.

When to apply:

Applications shall be lodged no more than six months and no later than 15 calendar days before the start of the intended visit.

Travel Agency Information:

The Chinese Travel Agency is responsible to lodge all information concerning the trip (medical insurance for each participant, accommodation, flight reservation, in bound agency information of the European partner agency, tour guide information, copy of the white badge).

Appointment:

Appointments have to be made with the company VFS Global via the internet address: https://visa.vfsglobal.com/chn/en/che

The main destination of your visit must be Switzerland, but the visa issued will permit you to travel in all Schengen countries (unless stated otherwise on the visa).

In Mainland China a visa fee (equivalent to 80 EUR) and service fee must be paid by bankcard in RMB upon acceptation of your file and is non-refundable. The visa and service fee is published on the VFS Global website.
