



## Checklist for a Visitor Visa (Schengen Type C)

**Submission of visa applications are by appointment only.** Applications can be submitted **up to** 6 months to **at least** 15 days prior the intended travel date.

Appointments are made via VFS at <https://visa.vfsglobal.com/hkg/en/che/> or by phone **3018 3030**. The appointment is free of charge. All applicants are required to submit their application **in person** and **on time** at the Consulate General.

Please submit the documents in the order given below, please do not staple any documents:

1 <a href="#">Schengen (type C) visa application form</a> duly completed and signed by the applicant In case of minors (under 18 years of age): both parents will need to sign the form and add a copy of their passports and of the birth certificate. A copy of a letter of consent of parent(s) is required if the child is travelling unaccompanied or with one parent only. 2 identical <b>passport photos</b> taken in the last 6 months (consult the requirements on the <a href="#">website</a> )	<input type="checkbox"/>
<b>Valid passport</b> or official travel document and one (1) copy thereof (data and signatures pages) Passport must be valid at least 3 months beyond the intended return date and have at least 2 blank pages	<input type="checkbox"/>

<b>Hong Kong or Macau Identity Card</b> and one (1) copy thereof	<input type="checkbox"/>

<b>Invitation letter from the host(s) in Switzerland</b> in German, French or Italian and copies of the <b>host's passport or ID and, if applicable, Swiss residence permit.</b> <i>The host must send the letter and attachments at least one day prior to appointment, either by fax (3509 5050) or by email (<a href="mailto:hongkong.visa@eda.admin.ch">hongkong.visa@eda.admin.ch</a>). <b>Confirmed round-trip flight reservation between Switzerland and Hong Kong or Macau</b> If visiting other countries within the Schengen Area, flight, train, bus or rental car bookings <b>must</b> also be submitted accordingly	<input type="checkbox"/>
<b>Accommodation reservation(s) for every night</b> spent in the Schengen Area, if not always staying with the host or if travelling in other countries within the Schengen Area <i>Hotel bookings; rental contract for chalet/apartment; utility or property tax bills if the property is self-owned</i>	<input type="checkbox"/>
<b>Proof of financial means</b> Bank statements of the <u>last 3 months</u> stating your full name and address <i>Credit cards statements or deposits are <b>not</b> accepted as proof of financial means</i>	<input type="checkbox"/>
<b>Proof of employment</b> Leave letter from current employer stating the position in the company, monthly salary, the purpose and duration of intended trip as well as the date of returning to work <b>or</b> <b>Proof of education enrolment</b> Letter from current school or university confirming the enrolment, stating the nature of study, the purpose and duration of intended trip as well as the date of returning to study	<input type="checkbox"/>
<b>Travel health insurance issued by a Hong Kong, Macau or Schengen based company</b> Confirmation, coversheet or policy with schedule of benefits including: <ul style="list-style-type: none"> <li>• First name, surname and date of birth of applicant</li> <li>• Coverage for <u>all Schengen member states or worldwide</u> and total duration of intended stay</li> <li>• Minimum coverage of equivalent of HKD300,000 for emergency medical expenses and repatriation costs</li> <li>• Letterhead with the address and contact details of the insurance company</li> </ul>	<input type="checkbox"/>

**Please note that:**

- **No guarantee** can be given that the visa will be issued.
- If your documents are not in a Swiss language (German, French, Italian) or English, **they need to be translated in one of the aforementioned languages.**
- **Supporting documents from Mainland China** (e.g., bank statements, proof of employment, travel insurance or itinerary etc.) **will not be accepted** and that applicants with such documents will be referred to a Swiss representation in Mainland China.
- The Consulate General of Switzerland reserves the right to ask for **additional documents.**
- Applications are to be submitted at the Schengen representation of the country of your main destination. Visitors who spend equal time in several Schengen states are required to apply for the visa at the representation of the country where they enter the Schengen area. If no main destination can be determined, the representation of the Schengen Member State whose external border the applicant intends to cross first, must deal with the application.
- No copies are made on your behalf and **incomplete applications will not be accepted.**
- The **visa fee** has to be paid (either cash or with Visa/Mastercard) when submitting the application. Please check our [website](#) for the current fees in HKD, these are subject to changes at any time and without prior notice in relation to exchange rate fluctuations. The visa is free of charge for spouses and children of EU/EFTA nationals, and children under six years of age.
