Requirements for the applicant's visa application and appointment at the Embassy
 □ Ethiopian, Djiboutian or South Sudanese nationality □ For any other nationality: Valid Ethiopian Residence Permit □ If you do not have a valid Ethiopian residence permit, you must first contact the Ethiopian migration authorities to regularise your stay in the country.

Translation

All documents written in Amharic, Oromia or Tigrinya need to be translated into German, French, Italian or English by one of the Embassy's officially recognized translation offices (see "Legal practitioners used by the representation" on our website).

Make sure that the information on your documents is correct. Names in Amharic, Oromia, Tigrinya and English must be written in the same way on all documents, including passports.

**Legalization

All foreign civil status documents and court decisions must be legalised before being submitted to the Swiss representation:

Thorough verification of genuine and fraudulent certificates

As a general rule, foreign civil status documents to be submitted must undergo a thorough verification of their authenticity, which may take several months, by an authorised law firm/organisation selected by the Embassy. For this purpose, please submit the following to the Swiss representation

Additional documents and fees may be required, depending on the conclusions or the requirements of the authorities concerned in Switzerland.

Fake civil status certificates are reported to the appropriate authority

Interpreter

If the applicant's level of proficiency in either of these languages is insufficient, the applicant will be asked to bring a translator from one of our approved translation agencies (see "List of Translation Offices" on our website). The translator must provide proof of identity in the form of a valid, translated national identity card and/or passport.

Fees

All family reunification fees are listed on our <u>website</u> and are **payable in cash** at the ETB at the time of submission.

The following fees are due at the time the application is submitted and is not refundable. If you withdraw the application or it is rejected the fee will not be reimbursed.

Further information

Changes in civil status that take place abroad must generally be notified to the partners' country of origin.

If you are planning to get married in Switzerland, please check the checklist for "marriage to be performed in in Switzerland" published on the website.

Subject: Request for an appointment for Family Reunification

The Embassy of Switzerland will only accept complete applications in the order above.

Applicants must submit **all required documents at the time of application**. Incomplete applications will **NOT** be accepted and will have to be rescheduled according to availability.

Before travelling to the Embassy, it is your responsibility to ensure that you are in possession of all the required documents.

Once submitted your complete documentation, your visa application will be forwarded for decision to the competent Immigration Authority of the Canton in which you intend to reside. The procedure takes a minimum of 12-24 weeks. Once the entry visa has been approved, you will need to bring your original passport or travel document to this Embassy to obtain your visa. The passport can be collected the next working day.
