Person or delegation expected to appear before the Swiss authorities or an international organization for an official mission, regardless of the type of passport.

| | Travel medical insurance Applicants for a uniform visa shall prove that they are in possession of adequate and valid travel medical insurance to cover any expenses which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment or death, during their stay(s) on the territory of the Member States. | | |
| | The insurance shall be valid throughout the territory of the Member States and cover the entire period of the person's intended stay. The minimum coverage shall be EUR 30 000. | | |

In addition to the Basic Required Documents 1- 5, applicants for Official Visit Schengen Visa should submit the following materials:

 Verbal Note or order of mission from the relevant ministry or authority.
 Copy of the official invitation from the Swiss authority or an international organization.
 For applicants who do not hold Tajik citizenship, copy of a residence permit/registration issued by the Republic of Tajikistan. The residence permit must be valid for at least three months after the date on which the applicant plans to leave the Schengen area.

Visa fee

- Free of charge

Personal appearance of the applicant is mandatory to submit a visa application, if the fingerprints have not been captured during the last 59 months. If the fingerprints have been captured during the last 59 months, the application can be filed through a representative duly authorized. (Power of Attorney)

Please note:

Once submitted to the consular agency in Dushanbe, your application will be sent to the Swiss Embassy in Astana. The round-trip transfer of your application can take up to three weeks. Additionally, the processing time at the Swiss Embassy in Astana can take up to 15 calendar days.
