

## Birth of a child in the Philippines to unmarried parents: entry in the Swiss civil status register

Documents to submit			
The following documents must be submitted:

The original documents will be sent to the civil status authority concerned in Switzerland and will not be returned. Additional documents may be required if necessary.			
Submission of documents to the Embassy			
Personal appearance is not required. You may send the documents to the Embassy via courier such as LBC.			
E-Apostille and e-certificates			
The Philippines now issues e-Apostilles and e-Certificates. However, the competent authorities in Switzerland may still request for the original and physical documents.			
Thorough verification			
The authenticity of the Philippine documents will be verified with the competent local authorities before transmission to the competent civil status office in Switzerland.			
Additional verification, documents and fees may be required through an external service.			
The registration of birth in the Swiss civil register can take a minimum of 4 months, if all documents are in order. The competent civil status authority is not bound by the outcome of the verification when making its decision.			

Fees

Entry of the birth in the Swiss civil status register is free of charge.
