Dear Swiss Citizens,

It is a pleasure to send you herewith the first consular infoletter of this Embassy.

In this first edition, we would like to familiarize you with the Swiss Abroad Act, as well as the Swiss Nationality Law. Even though you already possess the Swiss citizenship, this information may still be useful to you, and you can even pass on your acquired knowledge to your Filipino family members or Filipino friends and acquaintances with a close link to Switzerland.

We will also certainly use this infoletter to report about our consular consultations outside Manila and to promote the Swiss Club in Manila.

In this edition you will find a list of websites, which could be interesting for you, as a Swiss living abroad and also recipes of two Swiss delicacies.

We would like you to pay special attention to the section “Important Addresses in Case of an Emergency” at the end of the infoletter. This section was placed intentionally at the end, as we advise you to print out the page and store it so that you can retrieve this page quickly with all the telephone numbers and recommendations.

We thank you for your interest, we wish you a good start into the year 2019 and look forward to your feedback and suggestions.

Swiss Abroad Act

The Swiss Abroad Act governs the rights and obligations of Swiss nationals who live and travel abroad.

Personal responsibility

The Confederation's expectation is that each and every individual will assume personal responsibility when planning and undertaking a period abroad or pursuing an activity abroad, act in a risk-appropriate manner, and try to overcome any difficulties on his or her own.

Obligation to register

According to the Swiss Abroad Act, Swiss citizens who are not domiciled in Switzerland must register with a representation abroad (Embassy, Consulate General). Their data are entered in the Register of the Swiss Abroad, subsequently simplifying the provision of consular services including consular protection.

Swiss citizens who leave Switzerland must register with a Swiss representation within 90 days of deregistering from their Swiss municipality of residence.

Registration with a Swiss representation

According to the Swiss Abroad Act, anyone who is registered with a given representation and listed in the Register of the Swiss Abroad is regarded as a Swiss national living abroad. In order for individuals to exercise political rights, they must be included in the Register of Swiss Abroad.

Exercising political rights

Swiss citizens who have reached the age of 18 and are of legal age enjoy political rights regardless of whether they are domiciled in a Swiss municipality or abroad.

Swiss nationals living abroad with voting rights can register, deregister and reregister at any time for the purpose of exercising their political rights.

Social welfare

Under the terms of the Swiss Abroad Act, Swiss nationals living abroad who are in need can apply for social welfare even if they live abroad. Where an application is approved, the Confederation will provide welfare benefits or help the individual in need to return to Switzerland.

Swiss nationals are deemed to be in need if they can no longer support themselves through their own means and resources or through financial assistance from private sources or their country of residence.

Consular protection

The Swiss Abroad Act governs consular protection for Swiss nationals abroad who require emergency assistance or are situated in a crisis or disaster area.

However, there is no legal entitlement to consular protection. Cases are always assessed on an individual basis.

Swiss Nationality Law

Swiss citizenship is the status of being a citizen of Switzerland and it can be obtained by birth or naturalization.

Swiss nationals are citizens of their municipality of origin, their canton of origin, and the Confederation, in that order: a Swiss citizen is defined as someone who has the bourgeoisie of a Swiss municipality. They are entered in the family register of their place of origin. The manner by which a Swiss citizen acquires their place of origin differs depending on whether they acquired Swiss citizenship by filiation, ordinary naturalization, or facilitated naturalization.

Acquisition by filiation

A child is Swiss by birth if they are a child of a married couple of whom at least one parent is Swiss or they are a child of a Swiss mother not married to the child's father. A child of a Swiss father not married to the mother is considered Swiss by birth when a link of paternity is declared. A child adopted by a Swiss parent acquires Swiss nationality and the place of origin of the Swiss parent.

Acquisition by naturalization

Ordinary naturalization

Ordinary naturalization in Switzerland is a cantonal competency but regulated by federal legislation. The federal nationality law imposed to formal conditions which an applicant for naturalization must satisfy:

- Be a permanent resident.
- Ten years of lawful residence in Switzerland including three of the five years immediately preceding the application. The applicant can keep the first nationality. Dual or multiple citizenships are since 1992 possible in Switzerland.

In addition to the formal conditions, the federal nationality law also imposed material conditions which an applicant for naturalization must meet:

The applicant must be well integrated; must be familiar with the life in Switzerland; must not endanger Switzerland's interior or exterior security; must show respect for public order and security; must respect the values of the federal constitution; must be able to communicate in a national language.

Simplified naturalization

The decision to grant facilitated naturalization is in the sole responsibility of State Secretariat of Migration SEM.

The facilitated naturalization particularly benefits foreign spouses of Swiss nationals and children of a Swiss parent who do not yet hold Swiss nationality.

Foreign spouses of Swiss nationals who have lived in Switzerland for a year may apply for facilitated naturalization after three years of marriage, provided they have lived in Switzerland for a total of five years. People who have close ties with Switzerland may apply for facilitated naturalization even if they are resident abroad. In such cases, however, they must have been married to a Swiss spouse for at least six years.

Beside six years of marriage to a Swiss citizen, the applicant must have close ties to Switzerland, i.e. travelling regularly to Switzerland; must be able to communicate in a Swiss national language, being an active member of a Swiss club abroad etc.

Consular Consultations

In the past twelve months, the Swiss Embassy in Manila organized two consular consultations followed by an aperitif and dinner in cities outside Manila, where there are large Swiss communities. Recipes for a Berner Zopf (Bernese braided bread) and for a Käserösti (Cheese-flavored grated potato pancake)



Ingredients for a Berner Zopf

- 1 kg flour
- 1 ½ tbsp salt
- 42 g yeast, crumbled
- approx. 550 ml full cream milk, lukewarm
- 150 g melted butter, cooled down
- 1 egg yolk with 1 tbsp full cream, stirred
- Baking paper for the oven

Preparation

1. Mix flour and salt, form a well in the middle. Dissolve the yeast in a little bit of milk, then pour into the well together with the rest of the milk and butter. Knead into a smooth dough. Cover and let rise at room temperature until the dough has doubled in volume.
2. Cut the dough in half, form two strands and twist into a braid. Put on a tray covered with baking paper, let rise again for 15 minutes. Brush with egg yolk.
3. Bake in the lower part of the preheated oven at 200°C for 45-55 minutes.

Ingredients for a Käserösti good for 4 people

- Cooking butter
- 800 g boiled potatoes*, peeled and grated
- 1 tsp salt
- 20 g butter, in flakes
- 100 g Raclette or fried cheese, grated

Preparation

1. Heat the cooking butter in the frying pan and add the potatoes, sprinkle with salt. Fry gently at medium heat while turning it from time to time until golden brown, form into a cake. Spread the butter along the side of the pan and fry again for some minutes over very low heat. Turn the cake over using the lid of the pan and let it slide back into the freshly-buttered pan.
2. Spread cheese over the Rösti, cover and continue to fry for another 5 minutes until cheese has melted.

*Preparation of boiled potatoes for a perfect Rösti

1. Boil water in a large pan.
2. Add preferably same-sized, washed but unpeeled potatoes in the boiling water.
3. Cook potatoes with enough boiling water to cover them over medium heat for approx. 25 minutes until soft (if potatoes are big, cooking time will be stretched up to 50 minutes).
4. How to see if the potatoes are done: Stick a sharp knife into the middle of the biggest potato. If soft (no resistance can be felt) then all the potatoes are cooked.
