
She is accompanied by her husband Stephan Notter. Both are pleased to be in Doha and are also very much looking forward to the FIFA World Cup in 2022.

Consular services

Online desk for Swiss nationals residing abroad

The FDFA's <u>virtual counter</u> allows Swiss nationals who live abroad to manage their data online and to stay in touch with their consular representation more easily.

The online registration tool *Travel Admin App* (formerly known as "Itineris") is supported by the Helpline of the Federal Department of Foreign Affairs (FDFA) and is available to all travelers to record their data of their short term trips abroad.

This information will help the FDFA to locate and contact our fellow citizens more rapidly if a serious crisis occurs abroad. Registered travelers will receive a warning SMS and/or email if the security situation in a region suddenly deteriorates drastically. However, online registration is not an early warning system for natural catastrophes such as earthquakes, tsunamis, tornadoes, etc. Always follow the warnings and instructions of the local authorities in such situations.

All registered data will be treated confidentially and only used for the intended purpose. 30 days after return the travel data are automatically deleted.

Visa Services

COVID-19 has been hitting the headlines since March 2020 and restricts travel worldwide. Following the decision of the Federal Council in March 2020 not to issue Schengen visas anymore, the Visa Section and our external partner VFS Global suspended their services until further notice.

For so-called risk countries, the only possibility to obtain a Schengen visa is in a hardship case according to <u>SEM</u> (State Secretariat for Migration) regulations. Schengen visas and national visas (type D) are currently only being processed at the counter of the Embassy upon appointment and in clearly justified cases.
