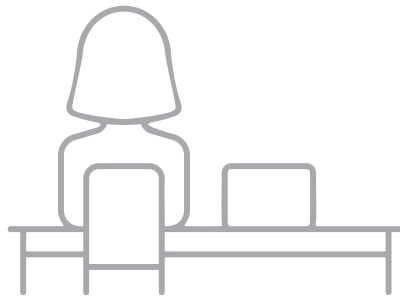

IMPROVING INTERNAL PROCEDURES FOR FUNDING LOCAL CSOs' PROJECTS



The public call which lasted from **20 June to 3 August 2018** was open for **the cities and municipalities of Šumadija, Western, Eastern and Southern Serbia**. The preparatory activities and info-sessions were held in June and July, the evaluation was conducted in August, and the **applications were approved in September 2018**.

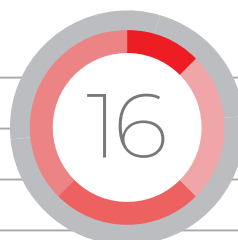

Ivanjica	Improving the Rulebook on the Methodology, Criteria and Conditions for the Allocation of the Funds for Projects implemented by CSOs, adopted in 2018, in terms of defining the criteria set, more transparent scoring of applications and the conflict of interest; developing all other regulations related to the determination of public interest and establishing the mechanism for monitoring and evaluation related to the projects of public interest implemented by CSOs
Bosilegrad	Improving the existing Rulebook on Financing the Projects Implemented by CSOs and the Rulebook on Financing Sports Associations and aligning with the newly adopted Government Decree that regulates projects of public interest; developing all other regulations related to defining public interest and monitoring and evaluation of such projects
Čuprija	Enhancing the Decision on Financing Projects Implemented by CSOs and improving its mechanism for the evaluation, along with developing other relevant regulations related to the definition and reassessment of public interest
Trgovište	Upgrading the existing Rulebook on Criteria and Conditions for the Selection of the Projects of Public Interest Implemented by CSOs, aligning the Rulebook with the newly adopted Decree, and fully developing the local policies defining public interest as well as the procedure for monitoring and evaluation
Raška	Upgrading the current procedure for financing of projects of public interest implemented by CSOs, developing all other regulations for defining and reassessing public interest and establishing the monitoring and evaluation mechanisms
Vlasotince	Improving the Decision on the Methodology for Financing the Projects Implemented by CSOs and the Guidelines for Funding CSOs in the area of good governance, especially in terms of participation of civil sector in creating local strategies and preparing annual budgets, and developing all other regulations defining public interest and establishing the mechanism for monitoring and evaluation
Negotin	Improving the existing procedure for supporting the projects of public interest implemented by CSOs, adopted in 2014, and aligning it with the newly adopted Decree; upgrading all other regulations related to the determination of public interest and setting up the monitoring and evaluation mechanisms
Bela Palanka	Improving the existing Rulebook on the Criteria and Conditions for the Selection of Projects Implemented by CSOs, adopted in 2015, in terms of more impartial and transparent selection procedure and aligning it with new Decree; developing all other regulations related to defining public interest and establishing monitoring and evaluation mechanisms
Nova Varoš	Improving the current Rulebook on Financing / Co-Financing Projects of Public Interest Implemented by CSOs (aligned with the newly adopted Decree) in defining public interest in order to prevent financing all CSOs that submit complete documentation; upgrading all other regulations related to the determination of public interest and establishment of monitoring and evaluation mechanisms
Smederevo	Developing the regulations for financing the CSOs other than the ones regulated by the only existing Rulebook on Criteria for the Selection of Programmes within Social Protection Area for financing the associations of PWDs, and developing the regulations for determination of the public interest as well as mechanisms for monitoring and evaluation of projects
Kragujevac	Improving local regulations for the determination of public interest and financing the projects implemented by CSOs, especially in terms of reassessment of public interest and establishment of the mechanisms for monitoring and evaluation of the projects implemented by CSOs
Zaječar	Upgrading the regulations on defining public interest and financing the projects implemented by CSOs, including monitoring and evaluation

The Swiss PRO Programme – Swiss Support for Enhancing Good Governance and Social Inclusion for Municipal Development – worth 5.8 million Euros will contribute to the improvement of the quality of life of Serbian citizens, particularly those belonging to the vulnerable groups.

The Programme activities will comprise improving the rule of law at the local

level, strengthening social cohesion and increasing the responsibility, transparency, efficiency and effectiveness of the local self-governments, as well as the participation of the population in the decision-making processes.
