**Please note that:**

The Trade Office of Swiss Industries in Taipei reserves the right to ask for additional documents and/or for a personal interview. All documents must be in English or one of Swiss official languages.

The national Visa application fee amounts to EUR 80.- and is due in TWD cash. The fee will be charged upon your submission and is not refundable.

Processing your visa application takes 2-3 working days. If your visa has not been approved by your submission, the entire procedure may take 8 – 12 weeks.
